Please find attached, the **First Draft** of the Examinations Timetable for your consideration.

This is to request that the Timetable be scrutinized for any omissions (including Retakes) or clashes of Courses and venues. The clashes and omissions should be reported to the Deputy Registrar, Examinations and Transcripts Division, with suggestions on how such clashes should be removed and on the times when the omitted Courses should be examined, the number of students registered for such Courses and the proposed venues. Any Course not being offered this Semester should be highlighted for deletion.

We further request that each College/School produces a simplified version of the Draft Timetable by highlighting the specific Courses for the benefit of the students and have it displayed on the Notice Boards for their perusal. The students should report their queries to the **Examinations Coordinators** and **Deputy Principals** in their respective Colleges/Schools.

Please indicate the correct number of students registered for the particular Courses in brackets against the Course Code to ease room allocation.

Submissions of reactions to the Draft should be made to **Room 512** Senate Building not later than **Friday 14 May, 2021**.

We also request that the Principals/Deans of the Colleges/Schools which do not use this general Timetable to start the process of timetabling for their respective Units, bearing in mind that the proposed date for starting the University Examinations as indicated in (i) and (ii) above.
